On this day, Wednesday, the third of June in the year two thousand and twenty-six, the undersigned:

- I. **Dr. Yudi Antomi, M.Si.** : Director of the Vocational School at Universitas Negeri Padang, overseeing the Study Program of Information, Library, and Archives, located at the Vocational School Building, UNP Campus, Jalan Prof. Dr. Hamka, Air Tawar Barat, Padang, West Sumatra, Indonesia. Hereinafter referred to as the FIRST PARTY.

Based on the above, in accordance with their respective positions and authorities, THE PARTIES agree and consent to prepare a draft implementation of the cooperation as regulated in the following articles.

Article 1

Article 3

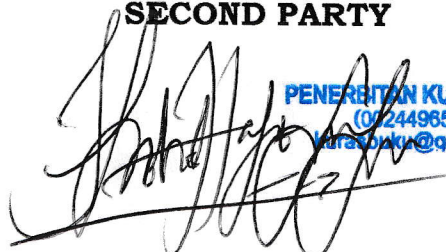
