On this day, Tuesday, the Twenty-Third of June in the year Two Thousand and Twenty-Six (23-6-2026), we the undersigned hereby declare :

1. **Afriva Khaidir, S.H., M.Hum., : Dean of the Faculty of Social Sciences, MAPA., Ph.D.**
Universitas Negeri Padang, appointed based on the Decree of the Chancellor of Universitas Negeri Padang Number 807/UN35/KP/2023 dated July 27, 2023 concerning the Dismissal and Appointment of Deans Universitas Negeri Padang for the 2023-2028 Period, in this case acting for and on behalf of Universitas Negeri Padang, Jl. Prof. Dr. Hamka Air Tawar Padang, hereinafter referred to as the **FIRST PARTY**.
2. **Mr. Haji Raccari Gia : Islamic Community of An Giang Province, n this case for and on behalf of the Islamic Community of An Giang Province which is domiciled in An Giang Province, Vietnam, hereinafter referred to as the SECOND PARTY.**

The **FIRST PARTY** and the **SECOND PARTY** shall hereinafter be collectively referred to as the **PARTIES** and individually as a **PARTY**. The **PARTIES** hereby state the following:

1. The **FIRST PARTY** is a State University with the legal status of Universitas Negeri Padang, implementing the Tri Dharma of Higher Education in the areas of Education, Research, and Community Service.
2. The **SECOND PARTY** is the Islamic Community of An Giang Province.

Based on the foregoing, the **PARTIES** agree to enter into a Cooperation Agreement concerning the Tri Dharma of Higher Education and the Impactful Campus Program with the provisions as set out in the following articles:

Article 1

AIM AND OBJECTIVES

3. To improve the quality of university graduates.
4. Other areas agreed upon by the Parties.

Article 2

SCOPE OF COVERAGE

The scope of this Cooperation Agreement includes:

1. Education
2. Research
3. Community Service
4. Other Tri Dharma of Higher Education.
5. Sustainable Development Goals

Article 3

IMPLEMENTATION OF AGREEMENT

1. This activity will be implemented in accordance with the scope of the Agreement and will be carried out by lecturers and students of the Faculty of Social Sciences, Universitas Negeri Padang.
2. This collaboration will take the form of research and community service.

Article 4

RIGHT AND OBLIGATIONS

1. The **PARTIES** shall have the right to benefit from the academic and non-academic collaboration.
2. The **PARTIES** shall be obligated to prepare administrative matters related to the collaboration.
3. The **PARTIES** shall assist in the smooth implementation of activities in accordance with the scope of the collaboration agreement.

Article 7
DURATION

1. This Agreement is valid for 3 (three) years, starting from the date of signing.
2. This Agreement may be extended, amended, or terminated in accordance with the written agreement of the PARTIES.

Article 8
ADDENDUM

1. If there is a disagreement between the PARTIES in carrying out this Cooperation activity, the PARTIES agree to resolve it through deliberation and consensus with mutual respect between the PARTIES.
2. If the deliberation does not produce an agreement, the PARTIES agree to resolve it legally.

Article 9

FORCE MAJEURE

1. This Agreement will terminate or be automatically cancelled if there are provisions of law or government policy or force majeure, namely conditions resulting from natural disasters such as flash floods, earthquakes, volcanic eruptions and/or war that do not allow this Cooperation Agreement to be implemented by the PARTIES.
2. The PARTY affected by force majeure is required to notify the other PARTY no later than 1 (one) month since the event occurred, as evidenced by a statement from an authorized official.

Article 10

CLOSING REMARKS

1. Matters that are not sufficiently regulated in this Momerandum of Agreement will be stipulated in an Addendum agreed upon by the PARTIES, which is an inseparable part of this Cooperation Agreement.
2. This Momerandum of Agreement is signed by the PARTIES in 2 (two) original copies, duly stamped and legally binding to be used as appropriate.
