This Memorandum of Agreement ("MOA") is made on and effective from the 1st day of August, 2023.

BETWEEN

INSTITUTION FOR PROFESSION CERTIFICATION, UNIVERSITAS NEGERI PADANG, an institution that is a part of Universitas Negeri Padang that certifies professional competencies with a BNSP License No: BNSP-LSP-1705-ID whose address is at Jl. Prof Dr. Hamka, Air Tawar Padang, West Sumatera, Indonesia, represented by its Head of Department, (hereinafter referred to as the 'LSP UNP')

AND

MODERN 5 TRAINING CENTER, CAMBODIA, a training center whose address is at #1580, national Road 5, Samaki Village, Russei Keo District, Cambodia, with represented by its Head of Modern Training, (hereinafter to as the 'Modern 5 Training Center')

Based on this Memorandum of Understanding, LPS UNP, and Modern 5 Training Center agree to establish the conditions for the Tourism and Hospitality professional certification program.

This agreement will be administered at LPS UNP by Universitas Negeri Padang and Modern 5 Training Center, Cambodia.

This Memorandum of Understanding witnesses as follows:

1. Assessments for certification will be conducted by LSP UNP according to requirements of each ASEAN certification's schemes (Front Office Supervisor, Receptionist, Waiter, Room Attendant, Baker, Butcher) registered at LSP UNP.
2. Candidates for certification shall be selected by Modern 5 Training Center and agreed by LSP UNP.
3. Modern 5 Training Center shall be responsible for all the assessment cost including travel expenses for assessment committee, assessors, and other incidentals.

4. Each host institution shall appoint a supervisor for an assessment program and gives advice, when necessary.
5. Each host institution has the right to expel any exchange individual who does not follow its established rules and regulations or does not have a good manner.
6. Share the relevant promotional materials to promote the cooperation between the two institutions.
7. Co-organized the relevant international certification programs or relevant training programs.
8. This agreement may be amended with mutual consent and in written statement in line with the MoU
9. This Agreement shall remain in effect for a period of five years from the date of signature.
10. Every notice, request or any other communication required or permitted to be given pursuant to this MOU shall be in writing, in English and delivered personally or sent by registered or certified post via air mail or by courier or facsimile number or email to the address or sent to the electronic mail address of Universitas Negeri Padang or Modern 5 Training Center, Cambodia registered (which shall be acknowledged by the other party) to the Parties at the address and facsimile number as stated below:

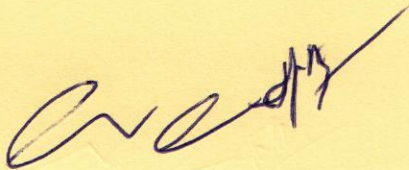

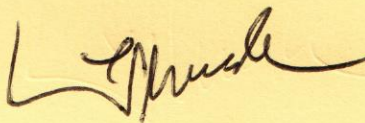
